Membership:

Membership dues cover a 12-month period. The dues are used to cover the operating expenses associated with having members (i.e. Elections, annual and periodic status reports, annual general meeting, etc.) Surplus funds from membership dues, if any, may at the discretion of the Board of Directors be used to fund programs/projects in accordance with the goals and objectives stated in the Constitution.

The amount of the dues will be set each year at the Annual General Meeting. Membership dues for the current period have been set at \$40.00 for individuals and \$75.00 for corporate memberships.

Individual Member is entitled to receive annual financial and operational report, periodic updates of the operations of the organization, attend the annual general meeting, run for a position on the Board of Directors and vote on all matters brought to the members attention.

Corporate member will have the same rights and privileges as individual members subject to part two of the By-laws.

The Armenian Orphans Fund is a charitable organization registered with Canada Revenue Agency for income tax purposes.
